

# **PSC 213/213W – The U.S. Congress**

## Course Description:

This course offers an overview of the legislative branch of the United States government. We will discuss the electoral process, the nature of representation, legislative organization, the committee system, floor procedure, congressional parties, and inter-branch relations. We will examine theories of lawmaking and the impact of institutional and electoral rules on legislative behavior and outcomes.

## Course Requirements:

There will be three major requirements for this course. First, attendance and class participation are mandatory. You are expected to attend each class, and you should let me

know when you will not be attending. In addition, you are expected to have read the required material. The reading list (subject to modification at my discretion) can be viewed at,

Each week, I will designate some students as discussion leaders for certain readings. I will allow students to volunteer for particular readings, but in the absence of volunteers, I will rotate through the students alphabetically by first name. Each student should lead discussion at least once during the semester. Participation counts for 50% of your final grade.

One short paper (4-5 pages in length), related to the course readings, will be assigned. The short paper will count for 15% of your final grade.

You will be required to write one research paper (10-15 pages in length).<sup>1</sup> I will make some suggestions for research topics later in the course. You must gain my approval for your topic before you begin. The main requirement is that you go beyond the class readings and perform some amount of original research. A 2-4 page proposal will be due on March 26<sup>th</sup>. In addition, we will discuss the research papers in class on April 30<sup>th</sup>. The final paper will be due on May 7<sup>th</sup>. I would highly recommend that you visit the writing center with a draft of your paper and I will be happy to read through a preliminary draft of your paper. Students who are taking the class for a W are required to submit a preliminary draft for review and writing will be a more important

factor in the grading for students taking the course for a W. The research paper will count for 35% of your final grade.

Please note that you must complete all of these requirements in order to receive a passing grade in this course.
